



**NOTICE OF RACE**  
**2012 President's Day Regatta**  
**HILL COUNTRY YACHT CLUB (HCYC)**

**Eligibility:** This is an open race. All keelboats are eligible. Yacht club membership is **not** a requirement for race entry. Non-HCYC member entrants and crews are welcome to the HCYC facility.

**Rules:** This race will be governed by the RACING RULES OF SAILING 2009 –2012, this Notice of Race, and by the current version of the Canyon Lake Sailing Instructions as modified for HCYC use. Other changes or modifications to the above rules and sailing instructions may be announced and posted at the skipper's meeting.

**Possible Classes:** J-22, PHRF Spinnaker, PHRF Non-Spinnaker, PHRF Cruiser and PHRF Big Boats. Three (3) or more boats may constitute a fleet. Actual fleets will be set and announced at the Skipper's Meeting.

**Races & Course:** This is a three race regatta around a course based on wind conditions on race day. The course will be set at the discretion of the Race Committee. The starting area will be between Canyon Park and Comal Park. Any change to the starting area will be announced at the Skipper's Meeting.

**Trophies:** Trophies will be based upon registrations received per class. 3-4 boats = 1 trophy; 5-7 = 2; 8-9 = 3; 10-15 = 4

**Timetable:** End of Registration: 5:00 PM, Friday, Feb. 17, 2012 (Late registration available at the skipper's meeting). Skipper's Meeting: 10:00 AM, Saturday, Feb 18, 2012

**Start of Race:** 12:00 PM, Saturday, Jan. 21, 2012 (Starting sequence begins at 11:55 AM). Results Presentation: On the HCYC deck, following the conclusion of the race. Trophies are custom made and ready in approximately 4 weeks or at the next scheduled event.

I will inform any and all crew members on my yacht of this waiver. I will also inform and instruct them on their responsibilities for safety. I agree that this waiver and indemnity is binding on me, on my heirs, representatives, successors and assigns. Each person on board during the event shall be deemed a crew person for all purposes. I certify that my yacht has the proper insurance and operational safety gear aboard in accordance with state and federal regulations including but not limited to any and all requirements of the U.S. Coast Guard. I FURTHER CERTIFY THAT I HAVE READ AND UNDERSTAND THIS WAIVER AND INDEMNITY AGREEMENT AS EVIDENCED BY MY SIGNATURE BELOW.
